

# Contract for Services provided by Barefoot Island Video (Fiji) Ltd.

The Select Package - includes both the Photo Package and the DVD Package. In addition we also include a Wedding Photo Slideshow of some of the highlights of the day set to music of your choice or we will select something appropriate. Two copies of the Digital Stills and of the DVD are included.

The Photo Package - Special shots of the bride and groom getting ready for the wedding, procession, the actual ceremony, formal and impromptu shots after the wedding, toast to the newlyweds, cake cutting, first dance and reception or dinner. Package includes approximately 250 - 300 digital still photos, color corrected and adjusted and or cropped. Also included along with your color images is a complete set of Black and White images They are delivered to you on DVDs in personalized cases for easy and safe storage. The photos can be printed in any size up to A1 or 24" x 33". Two copies are provided.

The DVD Package - Digital video of groom arriving, bride arriving, the wedding ceremony, reception, speeches, cake cutting, first dance, beach walks, etc. along with shots of the resort and wedding venue. The footage is artistically edited and delivered on DVD with interactive menu selections. We record your special day with the new Sony HVR-Z1U Professional High Definition camera. We offer your Wedding DVD in either PAL or NTSC formats in full screen or widescreen versions with interactive multimedia menus. We use Apple computers, Final Cut Pro and DVD Studio software. Two copies are provided.

## Terms & Conditions

1. Minimum deposit of 50% is required as a retainer at the time the wedding date is booked by the client.
2. The remaining balance is due 45 days prior to wedding date.
3. All deposits are nonrefundable in the event of a date change or wedding cancellation by the client for any reason. We will endeavor to accommodate a date change if it does not conflict with a prior booking.
4. DVD Movie and/or CD with digital images will be delivered in approximately two to four weeks from the wedding date.
5. If Barefoot Island Video (Fiji) Ltd. is unable to perform to the guide lines of this contract due to a fire or other casualty, act of God, act of terrorism, or other cause beyond the control of the parties, or due to a grave illness of photographer/videographer John Ferguson or Diana Ruff; and if Barefoot Island Video (Fiji) Ltd. is unable to provide a photographer that is agreeable to the client, then all fees paid by the client will be returned in full, but Barefoot Island Video (Fiji) Ltd. shall have no further liability with respect to the agreement. If Barefoot Island Video (Fiji) Ltd. is unable to perform to the obligations in this contract for reasons outside the sole control of Barefoot Island Video (Fiji) Ltd., they will not be liable for costs in excess of the amount the client has paid. This limitation of liability will also apply in the event that digital images are lost through camera malfunction, damaged in processing, lost in the mail, or otherwise damaged or lost without fault of Barefoot Island Video (Fiji) Ltd.
6. All rights to images created by John Ferguson/Diana Ruff will remain with John Ferguson/Diana Ruff. Barefoot Island Video (Fiji) Ltd. reserves the right to display any photographs made in conjunction with this wedding as samples of their work for the purposes of window and showroom exhibit, advertising, promotion on the Internet, publication, instruction and professional competition.
7. Photographing any specific moments are not guarantee by Barefoot Island Video (Fiji) Ltd. and they will not be responsible for any missed moments. The client may present Barefoot Island Video (Fiji) Ltd. with a list of suggested photos, but John Ferguson/Barefoot Island Video (Fiji) Ltd. is unable to guarantee that those suggested photos, or any image will be captured.
8. Client is responsible for all travel expense, lodging and meals for photographers to and from the wedding venue. These fees are included in the written quote attached to the contract after we have the details of your wedding unless otherwise stated on the quote.
